
The visit also included a brief training session with the ACT National Competition Cadet Team.

Research

ARC Victoria—research grant

The Australian Resuscitation Council (Victorian Branch) operates a grant scheme to facilitate research into the practice of resuscitation or first aid in the Australian setting. It aims to support high quality resuscitation research projects which require only modest funding with an emphasis on projects relevant to Australian conditions.

In 2013–14 grants of up to \$10,000 for experienced researchers and \$5000 for novice researchers may be approved for an area of basic or advanced life support or first aid which addresses scientific knowledge gaps and clinical research priorities.

Oecussi 2013

The highly successful Oecussi Ophthalmic project has been running for a number of years. The project involves financial support for the Royal Australasian College of Surgeons as well as sending a team of three volunteers to assist the surgeons and conduct projects within the community.

Danika Crolla, Anneka Hyman and Aaron del Pino accompanied the Royal Australasian College of Surgeons (RACS) on the annual trip to Oecussi, East Timor, from 12–20 July. The team assisted RACS with the Ophthalmic project including observing visual acuity tests, visual assessments, glasses dispensary, medications administration, surgical intervention and later post-operative observation. Some of the patients had not seen or had

good vision for a number of year and reacted with such joy. Aaron del Pino comments 'the experience was priceless and reflected how effective the project is and how honoured we were to be a part of it'.

While in Oecussi the St John team conducted a number of different community-based projects. The St John team visited the local police station and conducted interactive workshops and also provided resources including DRSABCD flow-chart stickers for each police car.

A visit was also made to the Dominican Republican

Dormitorio to deliver an education session to the children through song and dance—the students thoroughly enjoyed the session with a high level of engagement and inter-action.

They also visited Topu Homus Kutet and delivered an informal session with staff regarding health promotion topics such as effective hand hygiene, wound care and burns.

Anneka Hyman's personal observations

My time in Oecussi really gave me a new perspective on the problems faced in developing nations. A lot of our lessons needed to be modified to make them suitable to the people we taught and limited resources they would have after we left. It was encouraging to know that the basic skills that we were able to impart provided a chance of survival in circumstances where the nearest hospital was a day's walk away and specialist care was a 12 hour boat trip away. Topics like wound care and hand washing also had the potential to avoid such a trip. The team learnt so much from the people; their resilience in often very trying conditions was inspiring and always accompanied with a welcoming smile.

One of the best classes involved us instructing the local police force in Oecussi on basic life support. The lesson took place on the lawn out the front of the station with around 20 smartly dressed male and female officers performing CPR on dummies that we bought with us from Australia. We explained what

to do if they were the first to arrive at a Motor Vehicle accident, which occurred frequently, and handed out stickers with the flowchart for all the police cars. With no working ambulance in the district, it was likely that the police would be the only source of pre-hospital care and transport in these circumstances. It was a real privilege to be able to teach such a vital group in Oecussi.

Know how others really see you

You may think you already know how others view you—as a skilled facilitator or a manager who always brings out the best in her team—but you might be surprised. To find out what people really think, try these three things.

- 1. Seek out patterns in your paper trail. Look at past performance reviews or recommendations letters. What do people consistently say about you?
- 2. Examine your online presence. Google yourself. If there are any damaging or erroneous links, it's better to find out now (so you can take action), rather than having a potential client or employer discover them.
- 3. Conduct your own 360 review. Individually invite trusted colleagues, your boss, and your employees out for coffee. Tell them you're working to raise the bar professionally, and ask for their honest feedback: What do you do well? Where could you grow?

Leadership and emotional courage

I read this in another article I was reading about training leaders and thought it good enough to share here:

What makes leadership hard isn't the theoretical, it's the practical. It's not about knowing what to say or do. It's about whether you're willing to experience the discomfort, risk, and uncertainty of saying or doing it. In other words, the critical challenge of leadership is, mostly, the challenge of emotional courage.

Emotional courage means standing apart from others without separating yourself from them. It means speaking up when others are silent. And remaining steadfast, grounded, and measured in the face of uncertainty. It means responding productively to political opposition—maybe even bad-faith backstabbing—without getting sidetracked, distracted, or losing your focus. And staying in the discomfort of a colleague's anger without shutting off or becoming defensive.

Strengthen your confidence

Confidence isn't something you either have or you don't. It's a dynamic emotion that, like a physical muscle, needs exercise to grow stronger. Here are two ways to build and maintain it

- 1. Take inventory of your past. It's easy to doubt yourself and your abilities. But if you look at your track record, chances are that your successes outweigh your failures. And, more importantly, you likely survived your missteps and gleaned lessons along the way.
- 2. Focus on strengths. Most leaders are very strong in a few competencies, average in the majority, and weak in a few. Concentrate on leveraging what you're best at. Then, manage your average and weak areas so they don't detract from your effectiveness.

Medical Advisory Panel

The 16th meeting of the Medical Advisory Panel was held in Canberra on Saturday 3 August 2013. This page contains extractions from the latest MAP Bulletin, on revisions to St John protocols approved at the meeting.

Chest injuries

MAP agreed to simplify the first aid management of fractured ribs (AFA p. 275) and flail chest (AFA p. 277): bandaging of injuries is not required. This better aligns with treatment by doctors.

Methoxyflurane

MAP received a request to change the protocol concerning methoxyflurane. It was noted that the following were not included in the St John advice concerning the use of methoxyflurane.

Contraindications

- renal impairment or failure
- hypersensitivity to fluorinated anaesthetics
- · cardiovascular instability
- · respiratory depression
- · malignant hyperthermia

Precautions

- liver disease
- diabetic patient

MAP agreed to make no changes to the current protocol primarily because the changes requested were beyond what a first aider would be expected to accurately identify.

Further, MAP agreed that it was appropriate that not all contraindications identified by a manufacturer would be included in information provided to a first aider. A Frequently Asked Question is to be developed to explain why St John protocols may not be the same as provided on the manufacturer's product information sheet.

Choking

MAP agreed to the removal of the words 'or drinking' in the causes of choking (AFA pp. 14 and 91). Drinking too quickly does not cause choking.

Removal of the words: 'The most common causes of choking are: • Eating or drinking too quickly'.

Burns

MAP agreed to replace the following statement on p. 231 of AFA (and other similar references in the Burns chapter) on the management of burns:

Cover burn either with a non-adherent burns dressing, plastic wrap, clean dressing or loosely applied aluminium foil.

with Cover the burnt area with a loose and light non-stick dressing, preferably clean, dry, lint free (non-fluffy) material e.g. plastic cling film.

The second statement is what is endorsed by the Australian Resuscitation Council and provides greater clarity on the treatment of burns.

Frequently Asked Questions

MAP endorsed a FAQ titled: How does pressure bandage with immobilisation work?

MAP endorsed the First Aid Services Health Professional Credentialing Guidelines, which are designed to simplify the process of approving the skills that a health professional can perform when working with St John. Further information about the guidelines will be released later in the year.
